**RESERVED DECISION OF THE WHANGANUI DISTRICT LICENSING COMMITTEE**

**1. Application**

**Lisa Barrow** made the application on the prescribed form dated 27 June 2024. The applicant intends using the certificate at Riverview Four Square, Grocery Store Style Off-licence, where she has worked for two years. The applicant previously held a managers certificate but let it lapse. The Inspector comments the applicant is suitable to hold a managers certificate.

The application included evidence of obtaining the necessary License Controller Qualification. The applicant's colleague gave evidence of the applicant's experience, skills, and suitability.

**2. Decision Making**

In considering this application for a manager's certificate the licensing committee had regard to the following criteria under section 222 of the Act.

- *a) the applicant's suitability to be a manager:*
- *(b) any convictions recorded against the applicant:*
- *(c) any experience, in particular recent experience, that the applicant has had in controlling any premises for which a licence was in force:*
- *(d) any relevant training, in particular recent training, that the applicant has undertaken and evidence that the applicant holds the prescribed qualification required under [section 218](#):*
- *(e) any matters dealt with in any report made under [section 220](#).*

**3 Reporting Agencies**

The following reports were received under section 220 of the Act and taken into account during the decision.

**3.1 Police** – No opposition within report dated 4 July 2024.

**3.2 Licensing Inspector** – Full report assessing **Lisa Barrow's** credentials against the Acts criteria. The inspector has interviewed the applicant for industry knowledge and concludes that the application is complete and appears to meet the criteria of section 222 of the Act.

**4 Conclusion**

Based on the evidence provided to me within the application and statutory reports I conclude that **Lisa Barrow** meets the criteria to hold a Managers Certificate under the Act.

**5 Decision**

Accordingly, the application is **Approved** for issue for a period of one year.
